SANTA CLARITA VALLEY

Mark Carlson of Carlson Law Group, spoke on “Current Legal Economic Issues in Commercial Real Estate.” The event had about 55 attendees, and besides commercial practitioners, vendors, service providers, the group also included investors. The speaker dealt with the fiduciary duties of buyers/tenants and sellers/landlords. Also, the manner of holding title to multiple properties, including title held by special purpose entities. He also covered “green buildings,” and sharing of economic burden of “greening” between landlord and tenants. In addition, he covered Proposition 8 tax savings, and the effect on landlords and tenants of changing tenant densities. This was followed by a lively Q&A session.
